1. Welcome by Group Chairman

Rick Howard welcomed everyone to the meeting.

Rick Howard then explained who the Group Council is and what it does.

The Group Council consists of all the Leaders, Group Supporters, Parents of Beavers, Cubs and Scouts, Scout Patrol Leaders, the Sponsoring Authority, the District

Commissioner and the District Chairman.

A Scout Group is led by a Group Scout Leader and is managed by a Group Trustee Board. They are accountable to the Group Council for the satisfactory running of the Group.

The Trustee Board provides the vital support to the Group by being responsible for Group finances, Group property and equipment, Group insurances, providing sufficient resources to operate including fund raising, and adult recruitment, development of the Group and management of Group Safety Policy, and in doing so, complying with the Policy and Rules of the Scout Association. It sounds quite a lot doesn't it, but it is important and very rewarding.

The members of the Group Trustee Board are by law the Charity Trustees of the Scout Group, which is an educational charity, and they act collectively in the best interests of the Group. They are elected or approved by you, the members of the Group Council, at this meeting tonight.

The Agenda was publish with the Group Annual Report. I hope you have had time to look through the report as it is well worth reading..

3. Minutes of the previous AGM held on 12 November 2022

Group Chair Report

As your Chair, I am very pleased to submit my report on behalf of the Trustees for the 28th Croydon Scout Group Scouting Year 2023/24. This has been the first full year that I have been Chair and I remain more than happy to continue to support the Group in this function.

It has been another busy year for 28th Croydon Scout Group, with a Beaver Colony, two Cub Packs and a Scout Troop. We are extremely pleased to announce the expansion of the Group planned for this September, with a programme for a both a second Scout Troop and a brand-new Squirrel Drey. This will not only be an expansion in terms of numbers, but also the age range of the Group, with Scouting offered to young people from age 4 through to 14. This is an exciting time for us that I hope will bring many new people into Group.

After a break of 5 years, it was fantastic to see the return of our Family Camp back in May. It was great to see so many families enjoying a fun-packed bank holiday weekend at Cudham Shaws. I am a huge proponent of our Family Camps, as they bring people together and help forge 28th Croydon into one big family. I hope that everyone could see just how much hard work and dedication from our volunteers goes into organising and running these events. It's a huge effort, including people from outside the Group who give up their time for us. I would like to express my thanks to all those who made this happen. I look forward eagerly to the next Family Camp, which hopefully will be a more regular feature in the future.

This year saw us transition to a Trustee structure for the Group after adopting a new constitution at the last AGM. The new structure has already demonstrated that we can be more flexible and agile in our decision-making, whilst still providing the levels of governance and accountability required of a registered charity. I hope that going forward it will enable more people to make a valuable contribution to the Group.

I am pleased to report that this year we have managed to complete a significant amount of long-needed capital investment to our facility in Craven Avenue. This includes the long -awaited 'Tent Drying Facility' which should be completed very soon. The issue of tents being wet at the end of camp is not something that many people recognise. However, it puts a huge additional strain on our volunteers at a time when they have already given up so much of their time. For this reason, I see this project very much as an investment in our volunteers, relieving the pressure on them as much as possible and aiding in their retention. A huge thank you must go to Peter Devine and Graham Baker who have seen

this project from design through to construction. It could not have happened without them.

With regards to the Group's finances, we have finally had to make the difficult decision to raise subscriptions which had not risen since 2015. However, we have decided to stagger this increase over three years, subsidising the deficit from reserves in the interim. I am extremely confident that the Group's long-term finances are now on secure footing, with our regular income covering the ongoing cost of delivering our activities and maintaining our assets. This leaves our fund-raising activities to purchase new assets and expand the scope of our activities.

And now some more thanks. Firstly, I would like to thank all of our volunteers who actually deliver our Scouting activities. Without these people giving up their time and effort, there would be no 28th Croydon Scout Group. To all the leaders, volunteers and helpers I would like to extend my wholehearted thanks. These selfless individuals are the lifeblood of the Group and we literally could not do it without them. Especial thanks go to Claire, our Group Lead Volunteer who continues to go above and beyond. I would also like to express my thanks to Amy Morgan, who combines the role of Section Leader and Trustee with what seems like endless energy and enthusiasm.

I would like to thank individually all the Trustees and encourage others to join us the 28th Croydon team in what is a hugely rewarding experience. In particular, our Treasurer Pat Kingman, who continues to do a fantastic job in this role. I would like to thank our Parish Priest and Sponsoring Authority, for their continued support to the Group both spiritually and financially.

Finally, a very big THANK YOU to our young people who represent our Group in such a brilliant manner. They remain a source of both pride and inspiration.

Finding volunteers for these initiatives is crucial, but first, we need to showcase the enjoyment and fulfilment of adult volunteering.


Special Recognitions

It was a great day out with the Cubs taking the opportunity to try something new.

In June we held our summer camp on the Groups adopted site at the top of the hill at Frylands.

Once we arrived on site, the first job was to put up our tents and sort out our kit. We then needed to fill our water containers and collect firewood, as we cook on alter fires, so we needed plenty of wood.

When all the jobs were done, we headed off for a walk around the site before supper and bed.

We had a busy weekend with a mix of Scouting and fun activities. The Young Leaders worked with the older Cubs to set tracking trails for the younger ones. The Chief Scout Awards 2022-2023

Every Section has a number of Challenge Awards. They grow naturally from the activities run by the sections, and challenge the young people to use the skills they have learned. By undertaking a Challenge individually, or as a member of a group, members can earn a badge in the Colony, Pack or Troop. All the Sections have a top or key award.

For Beaver Scouts, the top award is the Chief Scout's Bronze Award. To be awarded this, a Beaver Scout must earn the six Challenge Awards and at least four Activity Badges.

For Cub Scouts, the top award is the Chief Scout's Silver Award. To be awarded this a Cub Scout must earn the seven Challenge Awards and at least six Activity Badges.

For Scouts, the top award is the Chief Scout's Gold Award. To be awarded this a Scout must earn the nine Challenge Awards and at least six Activity Badges.

Description of the Charity's trusts

Type of Governing Document:

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

How the Charity is constituted

This Group Trustee Board exists to make sure the charity is well-managed, risks are assessed and mitigated, buildings and equipment are in good working order, and everyone follows legal requirements and the organisation's policies and rules. Their support helps other volunteers run high quality and safe programmes that gives young people skills for life.

Risk and Internal Control

Group Treasurer's Report to the Accounts for 2023-24

1. The Group would like to acknowledge and sincerely thank the parish of Our Lady of the Annunciation, Addiscombe for their continued help and support. Over many years the parish have provided the Group with financial support and they continued to do so in 2023/24 with payment of the following utility bills:

Council Tax £ 65.28

Electricity £ 751.85

Gas £ 221.15

Water Rates £ 391.14

Total £1,429.42

Based on 66 children in the Group at 31st March 2024, this assumes an average of £21.66 per child and without the help of the parish subs would need to increase by £7 per term.

- 2. In 2023/24 subscriptions remained at £30 per term. Subscriptions for the Autumn (September December); Spring (January Easter) and Summer (Easter July) should be paid at the beginning of each term and the Group's preferred method of payment is by on-line (internet) banking. Subscriptions are reviewed each year but have not risen since 1st April 2015.
- 3. However, due to the continued increase in the membership fees levied by the Scout Association, we have had to increase subscriptions to £32 per term on 1st April 2024.
- 4. We received the sum of £1,831.56 representing our Gift Aid claim for the 2022/23 tax year. This is a valuable source of income to the Group and I would like to take this opportunity to thank all parents for completing the declarations for the Gift Aid scheme. I am proud to say that as at 31st March 2024 the Group is almost 100% Gift Aided.
- 5. Despite the Group's accounts showing an excess of £10,299.19 this included the

- £5,000 legacy received from Kevin Moynihan, the collection of £2,659 received in memory of Kevin Moynihan and £3,054 received for Family Camp. If these amounts were taken away, we would actually have a deficit of £413.81.
- 6. EasyFundraising has helped us to raise an additional £178.72 by just shopping online. We have 57 supporters at present. When shopping on-line, go to www.easyfundraising.org.uk, and once you are logged in, select the retailer you want to buy from. There are no extra costs to you but the Group benefits.
- 7. The Group did not receive any further funding from any organisations. This is usually a valuable source of income for the Group. If any parent is a member or an organisation that funds charitable organisations for either fundraising events or work carried out in the Group, we would be pleased to hear from you.
